Not-for-profit treatment center in Collier County providing affordable mental health and substance abuse services to everyone in need. In addition to helping children with behavioral, emotional and substance abuse challenges, the Center provides counseling and rehabilitative services to adults in crisis and individuals with persistent mental illness.

Access and Urgent Care Services are provided on a walk in basis and no appointment is necessary. In this traditional Walk in Clinic model, individuals can be seen and accessed by a qualified clinician on the same day services are requested. Clients are initially clinically triaged by a mental health counselor to determine the level of care (emergent, urgent or routine) and the appropriate services needed. In addition to providing the initial triage, the Access department conducts the clinical assessment, schedules appointments, makes referrals, completes the admissions paperwork and conducts a financial assessment for all new clients

Adult Community services are designed to provide support, in the least restrictive environment, for individuals who suffer from persistent mental illness and have long-term

needs.

Adult Substance Abuse services are designed to help individuals who experience problems - legal or other - related to the use of alcohol or other drugs. The Center offers various levels of treatment, including aftercare, for individuals in addiction recovery.

Adult Outpatient and Medical Services are provided to assess mental health problems and determine a treatment plan for solution-focused care.

Children's services include comprehensive assessment and treatment programs, as well as community-based prevention services. The continuum of care is a collaborative effort of David Lawrence Center, the Department of Juvenile Justice, Collier County Public Schools and other public and private service providers

Acute Care services are available 24 hours a day, 7 days a week, by walk-in or telephone. These services are designed to support emergency mental health and substance abuse needs of children, adults, and families.
