- Successful meetings were held within the last week with Red Cross and Miami Dade County Parks and Recreation concerning strong possibilities that they will offer host sites for EEP (Employment Enhancement Project) internships.
- Under the EEP project, in the Southern Region, 17 consumers were employed and there were 10 active internships.

### 2. iBudget

➤ Training is being held throughout this month by Gabrielle Morales regarding the new iBudget layout. Support coordinators, you are advised to take this beneficial training. There are no training credit hours given for this training.

#### 3. Documentation

All service requests and <u>annual support plans</u> require the determination of medical necessity be made by our office. Support coordinators, you are

still required to provide us with supporting documentation to justify the service request. Please refer to the Handbook requirements for services or refer to the SFR training held for support coordinators.

#### 4. Hearings

➤ Please remember to withdraw any hearing request accordingly. We ask that you send the withdrawal to Ms. Ariadna Martinez's attention at <a href="mailto:ariadna.martinez@apdcares.org">ariadna.martinez@apdcares.org</a> or 305-377-5022 but also to the Waiver staff that processed your SFR.

## 5. Support Plan/Case Note Issues/Service Requests

a. When submitting a Supplemental Funding Request (SFR) for your consumer you must submit all supporting documentation for existing services – we recommend the most recent documents for approximately 6 months. Additionally, you must provide justification for the new or increased service you are requesting. Often times schedules are needed to get a complete picture of the consumer's day and to ensure services do not overlap. Documentation for the caregiver is most beneficial when you are indicating the caregiver cannot assist the consumer. Efforts made to secure natural/community resources is critical for you to document in the support plan.

Please complete the Costplan Adjustment Worksheet correctly. It must include ALL services the consumer will receive in both the current and prorated portion. Our office will not be completing or correcting this document for you so you must complete it and submit it correctly as part of the SFR documentation.

b. Several of you have not been submitting complete support plans to our office as required by the Handbook page 2-85. As you are aware support plans are to be submitted to the Region for review and approval. Page 3-3 if the Handbook allows the Region to recoup money from the support coordinator for noncompliance. Providers, you should also take note to the recoupment that can also be done as well. Annual support plans are

required to be submitted with all supporting documentation to continue receiving services based upon medical necessity. Please ensure compliance.  c. Several support coordinators have submitted SFR requests such as ADT at the beginning of June 2014 to our office. This is not an acceptable practice. This is not allowing sufficient time for all parties involved. Based upon your SFR training done in earlier this year, you should be preplanning and request this service minimally 60 days in advance. We ask that you share this with your staff to ensure compliance.
<ul> <li>6. Other Issues</li> <li>Please ensure that the HIPAA notice is issued to all APD waiver consumers by 8/30/14. The consumer/guardian must sign the HIPAA Notice receipt. Support coordinators, you must send our office a copy of this signed document for each of your consumers by 8/30//14 to Nelly Perry's attention.</li> <li>Statewide Email addresses effective 7/1/14 – please refer to the email that I sent all providers yesterday. This information will also be posted on the APD website. Please share this with your staff.</li> </ul>
