WHEREAS, on March 9, 2020, the Governor of the State of Florida, Ron DeSantis signed Executive Order 20-52 declaring that a state of emergency exists in Florida and providing that "[e]ach state agency may suspend the provision of any regulatory statute prescribing the procedures for conduct of state business or the orders or rules of that agency, if strict compliance with the provision of any such statute, order, or rule would in any way prevent, hinder, or delay necessary action in coping with the emergency."

WHEREAS, and pursuant to the above Orders, the Agency for Persons with Disabilities issued Emergency Order Number 20-02 on April 8, 2020, which restricted the acceptance of admissions to the Agency's forensic and civil facilities.

NOW, THEREFORE, I, BARBARA PALMER, Director of Florida's Agency for Persons with Disabilities, pursuant to the authority granted by Executive Order No. 20-52, and upon Order of the State Coordinating Officer, find the timely execution of the necessary actions, mitigation, response, and recovery aspects of the State's emergency management plan, as it relates to COVID-19, is prevented, hindered, or delayed by the application of certain regulatory statutes, rules and orders related to the Agency for Persons with Disabilities (APD). Wherefore, I ORDER the following:

1. Emergency Order Number 20-02 is extended until May 31, 2020.

That is:

- a. APD developmental disabilities centers and forensic facilities shall not accept new admissions or commitments until after May 31, 2020, unless extended.
- b. The Agency shall not conduct in-person community-based competency training until after May 31, 2020, unless extended. If remote access utilizing telephonic or other electronic means is available to all parties and serves as an appropriate option, such remote competency training may continue.
