

**PROVIDER ADVISORY #2023-025**  
**UPCOMING APD ICONNECT TRAINING FOR BEHAVIOR SERVICE PROVIDERS AND**  
**REPORTING REACTIVE STRATEGIES**

**EFFECTIVE DATE: SEPTEMBER 22, 2023**

In preparation for the next phase of iConnect implementation, the Agency for Persons with Disabilities (APD) will provide APD iConnect Training from October 2-13, 2023, in anticipation of behavioral services functionality going live in the system immediately after. Additional details on the training and expected functionality rollout are below:

**Behavior Analysis Service Providers:**

- Training will be available on how to complete behavior services provider documentation including (but not limited to) service logs, behavior analysis assessments, service plans, quarterly reports, services eligibility, behavior designations, reactive strategies, and the communications necessary to ensure the plans and services are approved by the region.
- Behavior Analysis service specific training includes the pre-requisite courses listed on page two (2) of this advisory and the following course modules:

**Behavior Assistant Service Providers:**

**Providers utilizing APD iConnect and using Reactive Strategies:**

- Training will be available to report the use of reactive strategies using APD iConnect. All providers who are authorized to implement reactive strategies and are actively using APD iConnect will need to complete this training to begin reporting the use of Reactive Strategies using APD iConnect. This training will remain available for providers who are not using APD iConnect at this time. These providers will be required to report the use of reactive strategies in APD iConnect once they are onboarded into the system. **Other Behavior Designated Residential Habilitation Providers:**

- Please begin taking the required trainings as indicated in this advisory to be prepared for the anticipated launch of this functionality.
- Functionality for the residential habilitation services impacting Behavior Focus, Intensive Behavioral, and Enhanced Intensive Behavioral Residential Habilitation Providers is scheduled to go live in the future. APD is alerting these providers of the availability of these courses which will need to be taken before these services go live.
