Dear Sir or Madam:

Section 120.695(2)(b), Florida Statutes, requires each agency to review its rules and to designate those for which a violation would be a minor violation and for which a notice of noncompliance must be the first enforcement action taken. Section 120.695, (2)(c), Fla. Stat., directs each agency to review its rules and to certify to the President of the Florida Senate, the Speaker of the Florida House of Representatives, the Florida Joint Administrative Committee, and the Rules Ombudsman in the Executive Office of the Governor those rules that have been designated as rules the violation of which would be a minor violation no later than June 30, 2017.

To comport with the above requirements, the Agency for Persons with Disabilities certifies the following rules for which the first violation of which will result in the issuance of a notice of noncompliance:
